As you might be aware, in July of 2022, the La Crosse County Board voted to approve the Stormwater Infrastructure Grant Program which is being funded by the County's American Rescue Plan Act (ARPA) allocation. During the first round of applications, the Town of Onalaska submitted two applications for subdivision wide projects. Both projects were approved for funding and are in the final stages of design and ready for construction.

The County has decided to have a second round of applications, due April 17, 2023. The Town of Onalaska would like to submit an application for drainage improvement projects in Hidden Valley Subdivision. The Town will be applying for funding for the design phase of the project which requires a conceptual project plan.

The Town has been in contact with several property owners and is aware of several issues occurring within the upstream area of Hidden Valley Road. In order to gain knowledge of the overall drainage patterns, we would like the residents of Hidden Valley, who we have not been in contact with, to **contact us through the following email address, [Hiddenvalley@generalengineering.net](mailto:Hiddenvalley@generalengineering.net) to provide descriptions and pictures** of the stormwater issues that your property may be experiencing.

Using the feedback we receive through the emails, we will develop a conceptual plan to present to the subdivision residents at a **Public Workshop meeting at the Town of Onalaska Town Hall on March 22, 2023 at 7pm**. The purpose of this meeting is to discuss the potential design of the project in preparation of the application submittal and give residents, such as yourself, an opportunity to provide feedback.
